The AANLS invites proposals for a panel of papers on current research in Neo-Latin Studies to be held at the meeting of the American Philological Association (APA) in Chicago in January 2008. Our intent is to illustrate the diversity and richness of these studies and to underscore the importance of research concerning the complex international phenomenon of Neo-Latin literature.

We welcome papers on all aspects of the study of literary, historical, technical, and scholarly works written in Latin in the Renaissance and early Modern Period (to about 1800); we will also consider proposals dealing with more recent Neo-Latin.

Abstracts should be sent no later than **February 15**, **2007** to the President of the AANLS, Anne-Marie Lewis, either electronically to amlewis@yorku.ca or by mail to Department of Languages, Literatures, and Linguistics, Ross Building S 520, York University, 4700 Keele Street, Toronto, Ontario M3J 1P3, Canada. She will forward the abstracts anonymously to the organizer of the panel. Abstracts should be only one page in length.

In accordance with APA regulations, all abstracts for papers will be read anonymously by three outside readers.
