Proposing a New AANLS Executive Council

The members listed at the left have agreed to serve as Councillors for two-year terms, and the past executive has approved this amendment. In addition, it is proposed that the position of Secretary/ Treasurer be changed to Treasurer. We will need a 2/3 majority of individual members voting by mail to approve these changes.

San Diego

The AANLS Panel in San Diego, January 2007

Our annual session held at the meeting of the APA, "*Insignes Feminae*: Postclassical Women as Latin Writers," offered three perspectives on learned women in Italy and England who wrote in Latin.

Robert G. Babcock (Yale University) spoke on the study of Justinus, a thirdcentury Roman historian, by Genevra and Isotta Nogarola, two well-known learned sisters in fifteenth century Verona. He focused on manuscript annotations that have never been studied by previous scholars. Umit Dhuga (Columbia University) spoke on the cento to Pandulfo Malatesta by Angela Nogarola, the aunt of Genevra and Isotta, using a detailed analysis of the cento and its sources. Roger Fisher (York University) discussed possible connections between Neo-Latin poets and the widow who appears in the seventeenth-century novel The English Rogue by Richard Head.

The business meeting was cancelled due to lack of quorum.

Update: AANLS Panel in Chicago at the Annual Meeting of the APA/AIA (January 2008)

Our 2008 panel has been organized by Fred Booth (Seton Hall University). The topic is "Neo-Latin Studies: Current Research." Many thanks to all who answered the last-minute call for submissions. Fred is happy to report that several abstracts were submitted (and several more enquiries made) and that we will be fielding a panel of five speakers. The panel proposed consists of papers on a variety of topics: Francisco Cabrera's Benito Juarez, Reinhard Lorich's chreia on Eobanus, Filippo Beroaldo's Commentary on the Golden Ass, the Latin themes of Mary Stuart, and two Latin and Greek schoolbooks of the early modern period.

Details of the proposed panel have been sent on to the APA Meeting Committee according to the usual procedure. The full particulars of the panel will be announced in the next AANLS newsletter in August.

Neo-Latin News

Neo-Latin News is the official publication of the AANLS. It is published at the back of the academic journal *Seventeenth Century News* and consists of reviews dealing with Neo-Latin. It is edited by Craig Kallendorf of Texas A&M University. The journal will be converting from paper to electronic format in the near future and will be available through a link at the Texas Digital Library. The American Association for Neo-Latin Studies (AANLS)

The AANLS was formed in 1983 to promote the study and teaching of Neo-Latin language and literature from the beginnings of Italian humanism to the present day. The current constitution and by-laws date to 1990. The AANLS is affiliated with the American Philological Association (APA) and holds its annual conference at the January meeting of the APA. The AANLS is a non-profit organization with no political agenda or political affiliation. The AANLS website is http://www.aanls.ua.edu. It is in the process of being updated.

The AANLS currently has about thirty members and is hoping to attract more members, both in North America and beyond – academics, teachers, graduate students, and anyone interested in Latin beyond the Medieval period.

Neo-Latin is an exciting area of research and study in which much still remains to be done in regard to manuscripts, first editions, commentaries, pedagogy, and the cultural and historical environments of Neo-Latin texts.
