Neo-Latin Texts in a World Context: Current Research *Organized by Anne-Marie Lewis, York University*

The AANLS invites proposals for a panel of papers on current research in Neo-Latin texts in the Americas, Europe, Asia, Australia, and Africa to be held at the meeting of the Society for Classical Studies (SCS). Our intent is to illustrate the diversity and richness of Neo-Latin Studies: to underscore the importance of contemporary research in the complex, international phenomenon of Neo-Latin literature; and to give scholars an opportunity to share the results of their research and their methodologies with colleagues in the many disciplines that comprise Neo-Latin studies. We welcome papers on all aspects of the study of literary, historical, scholarly, legal, scientific and technical works written in Latin in the Renaissance and early Modern Period (to about 1800) and papers dealing with more recent Neo-Latin. Abstracts should be sent (and arrive no later than midnight EST on February 15, 2015), preferably electronically, to amlewis@ yorku.ca or by mail to Prof. Anne-Marie Lewis, DLLL, S561 Ross Bldg., York University, 4700 Keele St., Toronto, ON M3J 1P3 Canada. Abstracts are to be a maximum of 650 words (not including a brief bibliography). In accordance with SCS regulations, abstracts for papers are read anonymously by three referees. Please follow instructions for individual abstracts on the SCS website. In your cover note, please confirm that you are an SCS/AIA member in good standing, with dues paid through 2015.
